The Project Authority & Chairman, Blue Meadows Co-Operative Housing Society has submitted proposal for diversion of 0.0165 ha. Reserved Forest land in Pune District for laying of underground pipeline for water supply for drinking & Agriculture purpose at Village Kuravati, in Velhe Taluka Dist. Pune in the State of Maharashtra. The details of the forest land proposed for diversion are as under:-

The proposed pipeline having agriculture purpose in agriculture land in Village Kuravati, Tal. Velhe to solve the problem of drinking water & irrigation for agriculture use. The laying of pipeline proposed for 4" PVC pipeline three pipelines in one trench.

- 2.6 The site inspection report of the Sub Divisional Forest Officer, Bhor.
- 2.7 No alternate alignment is possible and the forest land required is lowest minimum.
- 2.8 The area belongs to Eco-value class-III having density is 0.1 to 0.2 (Dense Forest).
- 2.9 There is no tree felling involved in the project.
- 2.10 The area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 2.11 Proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 2.12 There is no violation of Forest (Conservation) Act 1980.
- 2.13 Proposed project is 16 kms from the boundary of Tamhini Wildlife Sanctuary.
- 2.14 The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12/12/1996.
- 2.15 Proposed Compensatory Afforestation over 1.00 ha. degraded Forest land in Gut No.3, Compt No.213 at Village Kuravati, Tal.Velhe, Dist. Pune and it is contiguous, suitable for afforestaion and management purpose and it is free from encroachment and an encumbrances.
- 2.16 Three alternatives have been examined in detail and have to come to conclusion that the alternative No. 2 (having 0.0165 ha) is most suitable for forestry point of view, i.e. minimum area involved and there is no cutting/felling of trees.
- 2.17 The User Agency has submitted an undertaking to defray the cost of Net Present Value.
- 2.18 The User Agency has submitted an undertaking to defray the cost of Compensatory Afforestation.
- 2.19 The User Agency has submitted an undertaking regarding the compliance under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 has been applied and is under process and shall be submitted before formal approval as per Government of India vide letter No.11-43/2013-FC, dt.3/12/2018.
- 2.20 The Sub-Divisional Forest Officer, Bhor has submitted proposal for acceptance or otherwise of the proposal with reasons i.e site specific justification as per as per Para 1.15 of the Handbook under FCA, 1980 issued by GOI.
 - "There is no alternative non forest land available and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. Proposed pipeline are for drinking and irrigation for agriculture land"
- 2.21 The Sub Divisional Forest Officer, Bhor and Chief Conservator of Forest (T), Pune have recommended the proposal for diversion of 0.0165 ha. of Reserved forest land.

- 2.22 The Chief Conservator of Forests (T), Pune has recommended proposal in additional conditions of the society shall pay Rs.50,000/- for construction of a waterhole along pipeline and will provide an outlet also from pipeline.
- 3.00 The Principal Chief Conservator of Forests (Head of Forest Force) Maharashtra State, Nagpur has recommended the proposal for sanction on the following conditional grounds. The recommendation letter of Principal Chief Conservator of Forests (Head of Forest Force), Maharashtra State, Nagpur, is enclosed on
- 3.1 The legal status of the forest land required will remain unchanged.
- 3.2 Forest land will be handed over only after required non-forest land for the project is handed over to the User Agency.

3.3 Compensatory Afforestaton:-

- a) Compensatory afforstation shall be taken up by the Forest Department over 1.00 ha. degraded Forest land in Gut No.3, Compt No.213 at Village Kuravati, Tal.Velhe, Dist. Pune at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3.4 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

3.5 NPV:-

- a) The State Government shall charge the Net Present Value (NPV) for the 0.0165 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No.202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II), dated 18/09/2003 as well as letter No.5-2/2006-FC, dated 03/10/2006 and 5-3/2007-FC, dated 05/02/2009 & File No.5-3/2011-FC(Vol-I), Dated 06/01/2022 in this regard.
- b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 3.6 No trees shall be felled during implementation of the project. In case tree felling is required the User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.

- 3.7 All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (http://parivesh.nic.in/)
- 3.8 The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 3.9 The pipeline shall be laid down 1.5 meter below the ground and after lying down of pipe line the ground will be leveled.
- 3.10 The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 3.11 No labour camp shall be established on the forest land.
- 3.12 Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 3.13 The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 3.14 No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 3.15 The forest land shall not be used for any purpose other than that specified in the project proposal.
- 3.16 The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
- 3.17 Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
