

Field Inspection Note of Sri K.Srinivasulu, Forest Divisional Officer, Kamareddy on 09.03.2021 in Nagireddypet Range area proposed for Diversion of 0.6066 Ha. of providing BT road from (0/0 Km to 0/606 Km) and 1/235 to 1/670 Km) from providing BT Road from PWD Road to Tikya (T) in Lingampet (M) of Kamareddy Division and District – Ramaipally Block, Ramaipally Beat Compt. No.688 & 689, Nagireddypet Range , Kamareddy Division in favour of District Panchayat Raj Engineer, PIU Division, Kamareddy District

On 09.03.2021 inspected the area proposed for diversion of **0.6066 Ha.** of Forest land for providing BT road from (0/0 Km to 0/606 Km) and 1/235 to 1/670 Km) from providing BT Road from PWD Road to Tikya (T) in Lingampet (M) of Kamareddy Division and District – Ramaipally Block, Ramaipally Beat Compt. No.688 & 689, Nagireddypet Range , Kamareddy Division in favour of District Panchayat Raj Engineer, PIU Division, Kamareddy District which is passing from reserve forest area in Kamareddy Division. The proposed area is passing through Compt. No. 688 & 689 of Ramaipally R.F Ramaipally Beat of Nagireddypet Section of Nagireddypet Range. I have verified the proposed road area passing through Compt.No. 688 & 689 and width of the road is 10 mtrs and length is 0.606 Kms. The Forest Range Officer, Nagireddypet has enumerated the trees which are falling in Ramaipally R.F. in Compt. No.688 & 689, there are (73) trees are found in proposed area. I have test checked the same and found correct. Density is 0.1 to 0.4.



The major species are, Vepa (*Azadiracta indica*), Chennangi (*Lagerstroemia parviflora*), Morri (*Buchanania lanzan*), Nallama (*Terminalia tomentosa*), Ippa (*Madhuca indica*), Palakodisha (*Wrightia tinctoria*), Moduga (*Butea monosperma*), Tuniki (*Diospyros melanoxylon*), Soppera (*Dalbergia paniculata*) etc., During my field inspection it is observed that the proposed BT Road from PWD Road to Tikya (T) in Lingampet (M) is falling in Eco Sensitive Zone of Pocharam Wildlife Sanctuary. The major fauna is Spotted Deer (*Axis axis*), Neelgai (*Boselaphus tragocamelus*), Black Buck (*Antelope cervicapra*), Bear (*Ursidae*), Wild Boars (*Sus scrofa*) etc., are existing in the forest. The proposed area falling in Eco Sensitive zone of Pocharam sanctuary is 0.6066 Ha.

Further it is submitted that I have searched for the other alternatives but there is no alternative land available except the present proposal. This is the barest minimum area i.e., required for providing BT road from (0/0 Km to 0/606 Km) and 1/235 to 1/670 Km) from providing BT Road from PWD Road to Tikya (T) in Lingampet (M) of Kamareddy Division and District – Ramaipally Block, Ramaipally Beat Compt. No.688 & 689, Nagireddypet Range, Kamareddy Division in favour of District Panchayat Raj Engineer, PIU Division, Kamareddy District. No work is started on the date in violation of Forest Conservation Act. There are no encroachments and claims in the R.F area that attracts the RoFR Act, 2006. The area is free from encroachment. There are no claims pending in RoFR Act, 2006. There are no endangered species that are caused or harmed due to providing BT road from (0/0 Km to 0/606 Km) and 1/235 to 1/670 Km) from providing BT Road from PWD Road to Tikya (T) in Lingampet (M) of Kamareddy Division and District.
