The Deputy Conservator of Forests, Jawahar has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/1392 dated 29.12.2017 & A/20/Land/73 dated 11.04.2018 Photo copy of the same are enclosed herewith for your ready reference. The Project Agency of this project is Manger, Public Relation (PR), Gujrat Gas Limited, Ahmedabad.

2.00 The Project Authority has submitted a proposal for diversion of 0.1921 Ha. Forest land for laying of Natural Gas Pipeline Passing through Near Wada to Ambadi Naka in Wada taluka of Palghar District. Therefore, the Project Authority is seeking GOI's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Forest land required for this Project is 0.1921 Ha. The details of land proposed for diversion are as under:-

- 4.00 The area involved in this proposal does not form part of any existing National Park, Wildlife Sanctuary or Nature Reserve.
- 5.00 Deputy Conservator of Forest Jawahar has certified that, The project area falls within 10 km from Tansa wildlife sanctuary also that area included in the draft notification of the Eco sensitive zone. the said Project will not have any adverse effect on the Wildlife within any National Park / Sanctuary.
- 6.00 Deputy Conservator of Forests, Jawahar has certified that there is no violation of Forest Conservation Act, 1980 and its guidelines have been committedly project authority.
- 7.00 This proposal is for laying Natural Gas Pipeline Passing through Near Wada to Ambadi Naka in Wada taluka of Palghar District. and project involved 0.1921 ha. forest land. Hence, Compensatory Non Forest land is not required. The degraded forest land is identified for Compensatory Afforestation from Compt./Survey No. 153 of village Mandwa, Tal. Wada, Dist. Palghar. The Project Authority is willing to bear the cost of Compensatory Afforestation as required by the GOI.
- 8.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted Necessary Certificates / Undertakings and Maps which are also enclosed in the proposal.
- 9.00 The User Agency has submitted the undertaking of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Right) Act 2006.
- 10.00 The Deputy Conservator of Forests, Jawahar has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 11.00 The Deputy Conservator of Forests, Jawahar has carried out site inspection on 26.09.2017. The site inspection report is enclosed in the proposal.
- 12.00 The Deputy Conservator of Forests, Jawahar's report is self-explanatory and this office agrees with the same.
- 13.00 As per the recommendation of the Deputy Conservator of Forests, Jawahar, this project is essential for Gas Distribution Network in various Taluka of Palghar District and in larger public interest and which required less 1.00 ha forest land. The Project Authority is ready to bear all the Government levies. The proposal is recommended with condition of recovery of Net Present Value, Cost of Compensatory Afforestation on 1 hector of degraded forest land.
