**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF**  
(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from Executive Engineer Provisional Division, PWD, Nainital for diversion under FCA-1980) of 3.33 ha. of forest land as Nainital Forest Division for non-forestry purpose. The project envisages the use of forest land for construction for motor road in Nainital District. The site inspection of the land involved in the proposal has been done by me on dated 15.10.2022

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 3.33 ha. RF /Village Forest

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**
