A proposal has been received by this office from Executive Engineer, Irrigation Division, PIU P.M.G.S.Y. for diversion under FCA-1980 of 9.194 ha. of forest land for non-forestry purpose.

The project envisages the use of forest land for Construction of Sahastradhara (Karlighad) to Naliwala Motor Road. The site inspection of the land involved in the proposal has been done by me on dated 23/08/2020.

On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-Classed/Other Forest measuring: -8.627 Ha. Reserve Forest + 0.567 Ha. Civil Forest + 0.000 Ha. Protected forest = Total 9.194 Ha.

No rare/endangered/unique species of flora and fauna is found in the area.


