

**FIELD INSPECTION NOTES OF SRI K. DAMODAR REDDY, S.F.S.,  
FOREST DIVISIONAL OFFICER, KINNERASANI WLM DIVISION, PALONCHA.**

**Date: 10.06.2021.**

The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide, Rc.No.7625/2020/FCA-2, dt: 29.07.2020 while forwarding the proposals for diversion of 1.246 Ha. forest land in Allapally RF in favour of the Superintending Engineer, Panchayat Raj, Region Office, Khammam for widening and up-gradation of the existing road from Allapally to Mylaram in Kinnerasani WLM Division has directed the undersigned to upload the information pertaining to Part-II of the proposal in the Ministry's website under FC Act, 1980 and Wildlife (Protection) Act, 1972 and furnish attested copy of the acknowledgment slip with the proposal. Further, Prl.CCF, TS, Hyd., Rc.No.8106/2020/WL-1, dt: 18.07.2020 while forwarding proposals under Wildlife (Protection) Act, 1972 in seventeen (17) sets directed the undersigned to process the same and furnish Part-III in Wildlife format with specific recommendations along with mitigation measures and also forwarded the ETS & DGPS / GNSS survey data pertaining to the proposed forest land to be diverted, vide Rc.No.19785/2018/FCA-2, dt: 29.11.2018. In this connection, I along with Sri K. Sydulu Reddy, Dy. Executive Engineer, PR, Manuguru; the Forest Range Officer, Allapally Range and staff concerned have inspected the forest land proposed for Diversion on 10.06.2021 and verified the entry and exit points of the proposed road alignment with respect to the Allapally Reserve Forest.



It is further noticed that the proposed road alignment with a length of 1246.47 mts. is already widened and upgraded to black top with 3.75 mts. width with a total width of 10 mts. including shoulders by the user agency and is passing through the Compt. Nos. 37 & 38, Allapally RF, Allapally Mylaram Beat, Allapally Range within Kinnerasani Wildlife Sanctuary limits with canopy density of flora less than 0.2 and the vegetation comprises of Musti (*Strychnos nuxvomica*), Tuniki (*Diospyros melanoxylon*), Chinta (*Tamarindus indica*), Jamun (*Syzygium cumini*), Gumpena (*Lannea coromandelica*), Chennangi (*Lagerstroemia parviflora*) etc. The source of arriving the density is the GIS layers of Telangana Forest Department website. There are no standing trees to be removed in the proposed forest land.

The terrain of the area is almost plain and as such the area is not subject to any erosion. The proposed area forms part of Kinnerasani Wildlife Sanctuary notified U/s 26-A of Wildlife (Protection) Act, 1972, vide G.O.Ms.No.54, EFS & T (For. III) Dept., Dt: 15.04.1999.

The requirement of Forest Land as proposed by the user agency is unavoidable and barest minimum for the project and also there is no alternative for the purpose of the project.

There are no rare / endangered / unique species of flora & fauna found in the area proposed for diversion.

There are no protected archaeological / heritage site / defense establishment or any other important monument located in the area.

The user agency has widened and upgraded to Black top the existing road in violation of Forest (Conservation) Act, 1980.
