

SITE INSPECTION REPORT OF SRI P.ANIL KUMAR, SFS, FOREST DIVISIONAL OFFICER, YELLANDU IN RESPECT OF DIVERSION OF 1.32 HA OF FOREST LAND FOR WIDENING AND UPGRADATION OF THE EXISTING ROAD FROM MARKODU TO PEDDURU OF YELLANDU FOREST DIVISION IN BHADRADRIKOTHAGUEM DISTRICT IN FAVOUR OF EE, PR DIVISION, BHADRACHALAM.

I have inspected the proposed diversion of 1.32 ha of Forest land for widening and upgradation of the existing road from markodu to pedduru in Valasala Beat of Valasala Section of Kachanapally Range on Dt.11.06.2021 along with Forest Range Officer, Kachanapally and concerned staff.

The proposed area is falling Damaratogu RF which is notified U/s.15 vide G.O.Ms.No. 420 F&RD, dt. 09.06.1975.

Verified the GPS survey points on proposed road from Markodu to Pedduru randomly and found correct.

The user agency has proposed road with a length of 1.31466 KMs falling in Yellandu Division with a width of 10.00 Mtrs. Thus the total area required for the project in Yellandu Division is 1.32 Ha is barest minimum for the project as per alignment.

Existing of Tree growth:

The vegetation of this area comes under Eco class II of Tropical Dry deciduous open forest having density > 0.1 and no trees to be enumerated in the proposed area. The area is having plain with equivalent slope with Red soils all over the applied area. There is no possibility of soil erosion in the area.

Flora and Fauna

The existing flora in the proposed diversion of forest is Acacia Nilotica (Nallatamma), Azadirachta Indica (Vepa), Acacia Leucophloea (Tellatamma) and other Misc species.,.

No rare/endangered/unique species of flora and fauna are found in the proposed diverted forest land during the inspection period. There are no unique or endangered flora and fauna.

No protected Archeology/Heritage site and Defense establishment or any other important monuments are located in the proposed diversion area.


The proposed area not falling in any national park wild life sanctuary, biosphere reserve, tiger reserve, elephant corridor, etc. But, the proposed area is falling in Eco Sensitive Zone of Wild Life kinnerasani Sanctuary.

Further, it is observed during the field inspection that, the road is completed. Therefore, I spoke to the user agency and the EE, PR division has informed that the road is completed on dt.08.04.2019.
