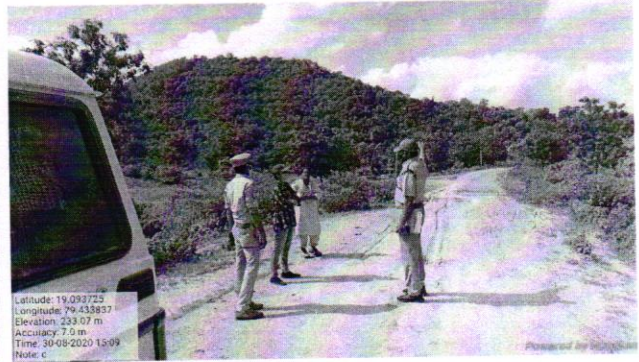
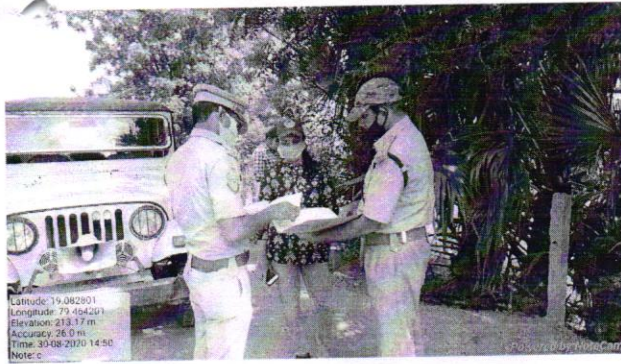
FIELD INSPECTION NOTES OF DIVISIONAL FOREST OFFICER, BELLAMPALLY
ON DIVERSION OF FOREST LAND TO AN EXTENT OF 2.6032 Ha FOR
IMPROVEMENT OF EXISTING ROAD TO BT STANDARD FROM R/f SH1 TO
BUGGA TEMPLE OF BELLAMPALLY RANGE IN FAVOUR OF PANCHAYAT RAJ
ENGINEER (PIU) DEPARTMENT, MANCHERIAL

- ❖ I along with the Forest Range Officer, Bellampally and the concerned staff have inspected the area proposed for construction of BT Road from BT standard from R/f SH1 to Bugga Temple of Bellampally Range in favour of District Panchayat Raj Engineer (PIU) Department on 30.08.2020. The details are as follows:-

- ❖ The total length of the proposed road is 4.33865 Kms and proposed width is 6.00 Mtrs which is passing through the Compt. Nos.332, 333 of Kannala Beat of Bellampally Section, Compt.No.328 of Madaram (S) Beat of Madaram Section and Compt.No.327 of Buggagudem Beat of Dharmaraopet Section and Compt.No.331 of Bellampally (W) Beat of Bellampally Section in Reserve Forest Block Tandur of Bellampally Range and the area required for diversion of Forest Land is **2.6032** ($433865 \text{ Rmt} \times 6 \text{ Mtrs width} / 10000 = 2.6032 \text{ Ha.}$).

- ❖ No alternative road is found to avoid use of Forest Land and also fragmentation of Forest Land.
- ❖ The area is having different type of vegetations, which is having 0.3 Density.
- ❖ In the proposed diversion area, no unique tree is found, no protected archaeological / heritage site / defense establishment or any other important monument is found in the area.
- ❖ The proposed area is not falling in National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor etc. There is no tree growth existing on the proposed diversion area, as it is passing along the road.
- ❖ The area proposed for diversion is barest minimum and unavoidable without alternatives for the project.
- ❖ No violation of Forest Conservation Act 1980 has been carried out by the User Agency.
