Submitted to the Principal Chief Conservator of Forests (Head of Department), Chennai with reference to Principal Chief Conservator of Forests Ref.No.TS3/43856/2018 Dated.12-11-2018 and Ref.No.TS3/31972/2019 Dated:14-10-2019 and 16-03-2021.

The proposed road connects Malaiyurkadu, Moolakadu villages with the Barigam and Konniyankadu villages. Currently the people of these villages are facing difficult situation to travel around the reserved forests about 40.00 Km distance via Jarugu, Arakasanahalli, Chinnampalli and Perumbalai villages to Malaiyurkadu village. The proposed road cut short the distance between Barigam and Malaiyurkadu villages to just 3.00 Km. The proposed formation of road from Barigam Konayankadu to Malayurkadu in Dharmapuri District is imperatively required considering the long term demand by the village peoples and demand raised in the Legislative Assembly.

The User Agency has furnished the under takings for the payment of cost of Compensatory Afforestation / Penal Compensatory Afforestation / Maintenance of Plantation / Protection of Plantation / Net present value / Additional Amount of Net present value / Lease rent and etc.

- 2) Under the circumstances reported by the District Forest Officer, Dharmapuri I recommend that permission may kindly be granted for the **formation of road from Barigam Konayankadu to Malayurkadu in Dharmapuri District** which is passing through Barigam RF in Dharmapuri Forest Division over an extent of 2.50 Ha subject to the following conditions,
 - (i) The total forest area to be utilized for the project shall not exceed 2.50 Ha to a length of 3.00 Km.

(ii) The User agency has to pay the cost of Compensatory Afforestation including maintenance cost and lease rent as fixed by the Forest Department.

(iii) The identified Compensatory Afforestation land of 5.00 Ha in SF.No.692/4 of Kammampatti village in Dharmapuri District has to be mutated to the Forest Department immediate after receipt of stage-I in principal approval.

(iv) The Compensatory Afforestation will be raised and maintained by the District Forest Officer, Dharmapuri as per rulings in force.

(v) Due to this project, there are 308 Nos of trees of various species have to be felled in the proposed area. As they are spontaneous in nature the prior permission of the Hon'ble Supreme Court should be obtained by the User Agency.

I request that the permission of the Government of India may kindly be obtained under Forest (Conservation) Act 1980 and communicated early.

There is no alternative route for this project and therefore the diversion of forest area is unavoidable.

The proposed formation of road from Barigam Konayankadu to Malayurkadu in Dharmapuri District is imperatively required considering the long term demand by the village people and demand raised in the Legislative Assembly.

The Compensatory Afforestation may be raised over the identified Compensatory Afforestation Land of 5.00 Ha in SF.No.692/4 of Kammampatti village in Nallampalli taluk which is suitable for management and protection point of view.

Under the circumstances, I recommend this proposal seeking diversion of forest land (2.500 Ha) for formation of road from Barigam Konayankadu Malayurkadu to Barigam RF of Dharmapuri Forest Division for the welfare of the people living in Malaiyurkadu, Moolakadu villages The User Agency has to obtain prior permission from the Hon'ble Supreme Court of India's central empowered committee for the felling and removal of 308 Nos spontaneous trees of various species.
