5.1 A proposal has been received by this office from The Commandant 57<sup>th</sup> Bn SSB Sitarganj for diversion under FCA-1980) of 0.99ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of SSB chauki Thapaliyal Khera The site inspection of the land involved in the proposal has been done by me on dated 29.12.2021

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PP/un-classed/Other forests measuring 0.99 ha.

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project.
