Hence One basecamp shed along with Basecamp watchers for 5 years is required for proper permission of forest area. <p>The proposals for forest land diversion to an extent of 4.7231 Ha for Improvement of Banswada to Uppalwai Road from Km 17/080 to 18/278 & 22/180 to 23/042 is recommended subject to approval of Basecamp with structure.</p>
