13) Specific recommendation of Sub-divisional Forest Officer Bhore for acceptance or Other-wise of proposal with reasons.

The proposal is recommended for acceptance; as the proposed Forest lands is useful for laying of underground water supply scheme for drinking & Agri. farm.

The Proposal for diversion of Forest land for laying of underground pipeline (3 pipeline in one trench) for drinking water to Blue Meadows co-op. HYS Society 21 member's houses from Grampanchayat water supply tank & farmers nearby society for agricultural land from back water of 'Parana Irrigation dam'. At- Kuravati, Tal. - Velhe, Dist.-Pune. Grampanchayat has agree to provide drinking water from their water supply tank. & it is come under Group Grampanchayat Ambegaon Kh. Tal. _Velhe, Dist.- Pune. The society has built housed & two drinking water tanks in Gut no 1. At village Kuravati, which is at high altitude. The Executive Engineer Khadakavasala Irrigation Div. Pune has sanction Pani Parvana for the period 2015-16 to 2033-34

It is observed that certain length of pipeline passes through acquired private land for Panshet dam project. & back water land. & Forest Gat no 3 of Village - Kuravati, Tal.- Velhe. Dist. - Pune. Forest area required is 0.0165 ha. There is no alternative to avoid forest land for laying of underground pipeline for drinking water & irrigation to agricultural crop.

There is no alternative non-forest land available and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. Proposed pipelines are for drinking and irrigation for agricultural land. Hence this proposal is recommended for diversion of the forest land for laying of underground pipeline.
