FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER, NAGARKURNOOL
IN CHERKUR RF OF CHERKUR BEAT ON 06.09.2021

I along with the Forest Range Officer, Nagarkurnool and staff have inspected the location of proposed project i.e., formation of road from NH 765 to Gangattu tanda of Veldanda Mandal & Construction of Bridge across Pedda vagu on Road from NH 765 to Gangattu Thanda at 5/400 to 5/600 of Nagarkurnool District in favour of District Panchayat Raj Engineer, PIU Division, Nagarkurnool proposals for diversion for diverions of forest land submitted by the User Agency which is falling in Compt.No.444 of Cherkur RF of Cherkur Beat/ Charakonda Section of Nagarkurnool Range and Achampet Division of Nagarkunool District.

The proposed location is falling in Compt No.444 of Cherkur beat of Charkonda Section of Nagarkurnool Range, Cherkur Reserve Forest. The user agency has proposed that the required forest area is about 0.9633 Ha for formation of road from NH 765 to Gangattu tanda of Veldanda Mandal & Construction of Bridge across Pedda vagu on Road from NH 765 to Gangattu Thanda at 5/400 to 5/600. During field inspection it is observed that, the density is 0.1 to 0.3 and average height is 3 mtrs and most of trees are fit for fuel. It is also observed that, the total no of trees is falling in proposed diverted area is 31 No's. I have test checked the enumeration list ie.,Sl.No.1,9, 15, 20, 25 & 30, which was recorded by the Forest Range Officer, Nagarkurnool and found to be correct.

The Forest area consists of the following species flora., *Chloroxylon swietenia* (Billudu), *Albizia amara* (Narlinga), *Holoptelea integrifolia* (Nemalinara), *Eucalyptus globulus labill* (Neelagiri), *ailanthus excelsa* (Peddamanu), *Cassia fistula* (Rela) and etc., and the major fauna present are Wild Boar, Peacock, Monitor Lizard & rabbits etc., There are no endanger/rare/unique species of flora and fauna is present in this area.

As per the User Agency the forest area is proposed for diversion is unavoidable and barest minimum required for the project. Since the project is important components of formation for formation of Road and Construction of Bridget across the Pedda vagu. The road serves the total population of 916 (Gangattu tanda, Konetiwada tanda, Ontigutta tanda, Badrigoni tanda, Iskabodu tanda). As there is no proper transportation facilities the school going children's were become Agriculture labour. The basic occupation of the people in this area is agriculture and the agriculture is totally rain fed. The main food crops are Paddy, Jowar, Cotton and Vegetables , other commercial crops are Black gram, Red gram, Chilies. The crop yielding is generally very good and needs to be transported to the nearest marketing center i.e., Adilabad so as the farmers shall get the better benefits and true value. During my field inspection observed that, no violation was occurred.

The proposed project will not adversely effect on flora and fauna.

FIELD INSPECTION REPORT OF THE SRI. ROHITH GOPIDI, IFS, FOREST DIVISIONAL OFFICER (FAC), ACHAMPET IN CHARAKONDA SECTION OF NGAGARKURNOOL RANGE ON 25.08.2021



I have inspected the proposed Road Project area along with Deputy Range Officer Charakonda and Forest Beat Officer. The proposed road from NH 765 to Ganugattu Thanda of Veldanda Mandal of Nagarkurnool District which is falling in Forest area of Comp. No.444 of Cherukur Reserve forest of Cherukuru Beat of Charakonda Section of Nagarkurnool Range. The project seeks to divert 0.9633 Ha of Forest Land.

Enumerated trees were marked on ground and a total of 23 trees have to be felled for construction of road. The area has sparse jungle growth and has a canopy density < 0.3 . Fauna like Wild Boar, Spotted Deer and Peacock are present.
