
SITE INSPECTION REPORT

1. A proposal of **Executive Engineer, PWD (R&B) Division Ramban** is recommended by DFO Batote in Parivesh Portal for diversion of Forest land under Forest conservation Act 1980 for non forestry purpose. The project envisaged diversion of 0.99 hac of forest land at Batote Forest Division in District Ramban in favour of **Executive Engineer, PWD (R&B) Division Ramban** for construction of road from Peerah (NHAI) to Kameti in the UT of J&K in Batote Forest Division. The site inspection of the spot involved in the proposal has been done by the Divisional Forest Officer Batote on 29-05-2022.
2. No protected / heritage site /defence establishment etc is located in the area.
3. Rare/endangered/unique species of flora and fauna found in the area, are Leopard, exists in the area. The said project may not effect their survival.
4. No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.
5. Whether site, where the forest land involved is located has been inspected by concerned Conservator of Forests (No).
6. Whether the concerned Conservator of Forests agree with the information given in Part-B and the recommendations of Divisional Forest Officer (Yes).


