A proposal has been received by this office from Executive Engineer, Rupnagar Head Works, Rupnagar for diversion (under FCA-1980) of 0.938 Ha. (0.778 Ha. area closed u/s 4/5 of PLPA, 1900 + 0.139 Ha. area delisted from PLPA, 1900 + 0.0207 Ha. PF area of AHC) of forest land for non-forestry purpose. The subject envisages the use of forest land for construction of Jeowal- Bhatoli-Baruwal- Massewal- Majher- Chikna- Nard Lift Irrigation Scheme, Falling within the jurisdiction of Forest Division and Distt. Rupnagar (Punjab). The site inspection of the land involved in the proposal has been done by me on dt. 16/02/2021 & 03/03/2021
