These are the pristine, undisturbed, ecologically unique lateritic fragile natural wilderness areas. The area receives heavy rainfall with an average of 3500 mm annually. The proposed area includes two components viz approach road and dumping site. Panchayat occasionally dumps the waste generated in the open area causing environment pollution.

The proposed area does not affect any declared or notified monuments of historical religious archeological or recreation importance.

Further, the Deputy Conservator of Forests, Honavar Division has opined that in the above ecological background and observations the proposed area for diversion may be consider after examining the alternatives depending on the project requirement.






