

SITE INSPECTION REPORT - NOT BELOW THE RANK OF DCF

(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from **Executive Engineer Ty. Division P.W.D. Nainital** for diversion under FCA-1980) of 2.73 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Construction of Kathgodam to Ranibag Section Bypass Motor Road NH No. 87(109) and 90 M. Span Steel Guider Motor Bridge under C.M. Ghosna No. 550/2019 year 2019-2020 District Nainital** constituency of nainital district under Honorable Chief Minister Declaration Number 329/2018. The site inspection of the land involved in the proposal has been done by me on dated 08-07-2021

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 2.73 ha. RF/Civil soyam.
