

10	Position of wildlife in general.	The proposed village of Parbatipur, Jamunali and Kadalimunda are coming under proposed Tiger Corridor area and Leopards are often seen crossing the NH-55. Apart from that another Wildlife like Jackal, Fox, Barking Deer, Wild Boar, Sloth Bear etc. are seen. Elephant depredation is also seen in the area.

All the 13 angle points were seen to have been erected out of which 5 nos. of angle points were done in Revenue Forest Area. They are A.P. No.-2 & 3 in Mouza, Jamunali and A.P. No.-7,8 & 9 in Kadalimunda Mouza. Apart from that stringing of conductor had been done from A.P. No.-7A to A.P. No-9.</p>
