During the field inspection as per demarcation of ground and DGPS maps it is noticed that, the total area of the proposed 220 KV double circuit line in Nizamabad Division is 3.294 with a length of 941.07 meters and 35.0 meters width and the maintenance of tree growth under the transmission line at required height is insisted to avoid erosion.  Thus, the proposed diversion of forest area as proposed by the User Agency is unavoidable and barest minimum for the project. Hence the proposals for forest land diversion to an extent of 3.294 Ha (a length of 941.07 meters and 35.0 meters width) are recommended for laying of 220 V double circuit line with multi circuit towers in Forest land to extended power supply to Yacharam Tanda pump house under Kaleshwaram lift scheme package-22 in Nizamabad Forest Division of Nizamabad District.
