





The Deputy Conservator of Forests, Alibag has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/1820, dated 06.02.2020 & letter No. A/20/Land/1830, dated 20.02.2020. Xerox copy of the same are enclosed herewith for your ready reference. The Project Authority of this project is General Manager, Pipelines (Projects) Bharat Petroleum Corporation Ltd., 2nd floor, ERP Building, 'A' Installation, Sewree Fort, Sewree (East), Mumbai.

- 2.00 The Project Authority has submitted a proposal for diversion of 22.9648 ha. Forest land for Construction of underground Petroleum products pipeline with OFC and its associated facilities from Mahul (Mumbai Suburban District) to Rasayani (Raigad District) State of Maharashtra. Therefore, the Project Authority is seeking GOI's permission u/s.2 of Forest (Conservation) Act, 1980.
- 3.00 The User Agency BPCL has highlighted that BPCL is a Maharatna Company of Government of India under the aegis of Ministry of Petroleum & Natural Gas and it is empowered to take decision for its capital projects. The project has been approved by BPCL board vide board resolution note dated 12.07.2018.

The expansion of refinery centric facilities envisaged at Rasayani includes Petrochemical facilities, White Oil Rail loading facilities & Lube oil Blending plants. The Petrochemical facilities envisaged required raw materials like Propylene, Ethylene,

Unconverted Oil (UCO) and Naphtha. The proposed Lube Oil Blending plant will receive Lube Oil Base Stock (LOBS) through pipeline. The proposed Naphtha pipeline is also proposed to be used for other white oil product for setting - up a Railway wagon loading facility at Rasayani, thereby developing this important mode of evacuation for BPCL's Mumbai Refinery.

The proposed pipelines from BPCL Mumbai Refinery to Rasayani is meant for the product like :- Propylene, Lube Oil, UCO, Multiproduct Pipeline.

The said pipelines will provide Energy Security to entire Maharashtra and part of Northern India. These pipelines will provide an alternate / additional evacuation point to Mahul Refinery. This is in line with the International practice for Refinery Evacuation and energy security requirements.

6.00 Divisional Forest Officer, Mumbai Mangrove Conservation Unit , Mumbai & The Deputy Conservator of Forests, Alibag has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under the Act have not been violated by the Project Authority.

- 7.00 The Deputy Conservator of Forests, Alibag has certified that 46.00 ha. degraded forest land as mentioned in below for Compensatory Afforestation and it is suitable for Afforestation and management purpose also it is free from encroachment and encumbrances.

The Project Authority has submitted an undertaking to defray the cost of Compensatory Afforestation cost at the prevailing wage rate.

- 8.00 The Deputy Conservator of Forests, Alibag has certified that the non-forest land proposed under the proposal is neither deemed Reserved Forest under the provisions of Maharashtra Private Forests (Acquisition) Act, 1975 nor identified as "Forest" as envisaged in the interim order passed by the Hon'ble Supreme Court of India dated 12/12/1996.
- 9.00 The Deputy Conservator of Forests, Alibag and Divisional Forest Officer, Mumbai Mangrove Conservation Unit, Mumbai has certified that the proposed project is not likely to affect any monuments, site of culture, historical, religious, archeological or recreational importance.
- 10.00 The Deputy Conservator of Forests, Alibag has certified that the Project area is beyond Karnala Bird Sanctuary and ESZ of Karnala Bird Sanctuary. The distance from Karnala Bird Sanctuary is 1.89 Km. The proposed alignment of Project is within deemed Eco-Sensitive Zone of Thane Creek Flamingo Sanctuary. The distance from Thane Creek Flamingo Sanctuary is 5.5 Km. and Sanjay Gandhi National Park is 11.2 km.
- 11.00 The project involves felling of 11677 trees of various species and girth classes in the area falling in diversion Girth wise break up is as under :-

- 12.00 The Deputy Conservator of Forests, Alibag & Divisional Forest Officer, Mumbai Mangrove Conservation Unit, Mumbai has certified that no alternate alignment is possible and the forest land required is the barest minimum.
- 13.00 Project Authority will obtain Permission of Hon'ble High Court will obtain for implementing the project in Mangrove areas as per Bombay High Court order dated 27.01.2010 in PIL No.87/2006, also the User Agency will obtain the permission of CRZ & Environment Clearance.
- 14.00 The Project Authority has not submitted the FRA - 2006 Certificate. Regarding this, the necessary undertaking by the Project Authority is submitted and the same enclosed in the proposal. The Project Authority may be asked to submit FRA - 2006 Certificate from Collector Thane & Raigad after Stage-I approval of the Govt. of India.
- 15.00 The Deputy Conservator of Forests, Alibag has inspected the proposed diversion area on dated 05.02.2020 & Divisional Forest Officer, Mumbai Mangrove Conservation Unit, has inspected the proposed diversion area on dated 23.08.2019. Site Inspection Reports are enclosed in the proposal.
- 16.00 As per the recommendation of the Deputy Conservator of Forests, Alibag & Divisional Forest Officer Mumbai Mangrove Conservation Unit, the proposal is for Construction of underground Petroleum products pipeline with OFC and associated facilities from Mahul (Mumbai Suburban District) to Rasayani (Raigad District) is a safe mode of transportation of Petroleum product that leads to reduce road congestion, lower energy consumption and is environmental friendly by minimizing gaseous emission in transit. The proposed pipeline is for public utility and for supply of aviation fuel to proposed Navi Mumbai International Airport. This project is recommended as this is an infrastructure development and public utility project for diverting the required forest land under Forest (Conservation) Act, 1980.
