FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER, SIDDIPET IN RESERVE FOREST LAND ON 18-12-2018.

Today, I along with the Forest Range Officer, Siddipet and their field staff have inspected the Reserve Forest areas proposed for diversion of 4.482 Ha. Forest Land in RF Girraipally for Errection of 220 KV DC Line in Siddipet District as detailed below:

The said area is passing through the RF to a length of about 1280.69 mts and width is 35 Mtrs as mentioned above. The canopy of this area is 0.2 to 0.4 and about 1722 trees are required to be removed from the said area. the dominant species in this area are 1) Are (Bauchinia racemosa), 2) Billa Kodisha (Ximenia Americana), 3) Budda Dharmi (Symphorema involucratum), 4) Chennangi (Lagerstroemia parviflora), 5) Chinduga (Albizia odoratissima), 6)Chinna Are, 7) Danthe (Gymnosporia spinosa), 8) Ippa (Madhuca Longifoliavarlatifolia), 9) Kanuga (Pongamia pinnata), 10) Kummariponiki (Givotia rottliriformis), 11) Manga (Randia tumetorum), 12) Moduga (Buteamonosperma), 13) Narlenga (Albizia amara), 14) Palakodisha (Wurightia tinctoria), 15) Ponna (Calophyllum inophyllum) and etc., Enumeration and valuation of the tree growth in proposed area is completed (list enclosed).

I have searched for other alternatives, but there is no alternative land available except the present proposal. This is the barest minimum area that is required for Errection of 220KV DC Line. No work is started as on date in violation of FC Act 1980. There are no encroachments and also claims in the RF area that attracts the RoFR Act 2006.

The user agency has submitted their undertakings to implement the following conditions.

- 1. The NPV of Rs. 35,99,046/- shall be paid by the user agency.
- 2. The Project Rs.87,65,089/- shall be paid by the user agency.
- 3. The area is free from encroachments and does not fall in wildlife protected areas, archaeological heritage site, important monument there are no claims pending under RoFR Act.2006.
- 4. There are no endangered species that are caused or harmed due to erection of 220 KV DC Line.

The District Collector, Siddipet has issued the RoFR certificate in Proforma-I as per instructions vide GOI, MoEF, Ref. 11-9/98-Fc (PT) Dt.05.07.2013 for linear projects, duly certifying that the process of identification of Rights under Forest Right Act has been completed in the District and there is no claim pending in the above said RF.
