Attention of the Director, M/s Padminee Plantations Pvt. Ltd is invited to the references cited.

The proposal for diversion of 0.3927 Ha of forest land for the subject project as submitted by the Director, M/s Padminee Plantations Pvt. Ltd in the reference 1st and 2nd cited has been forwarded to the field officers vide ref 3rd cited for processing the same under Forest (Conservation) Act, 1980 and amendments issued thereof.

The Chief Conservator of Forests, Hyderabad and District Forest Officer, Yadadri-Bhuvanagiri in the ref 5th and 6th cited respectively have submitted a detailed report in the matter and submitted the following information:

- The forest area proposed for diversion is inspected by the District Forest Officer alongwith his staff on 05.09.2017 to explore the possibilities of alternate ways to reach the field of the applicant to avoid fragmentation of forest block which is very small in extent of area 24.76 Ha only.
- It has been stated that there is a clear way from Somajipally Village to Patta Lands in the East side of User Agency land and the same is also found in the Revenue Village Map.
- The proposed RoW to the patta land through Somajipally RF is not essential and is avoidable keeping in view of fragmentation of very small forest block and will also have adverse effect on forest land, if the land is diverted for non-forestry activities and **recommended for rejection of the proposal**.

In view of the above, the Director, M/s Padminee Plantations Pvt. Ltd is informed that the proposals for diversion 0.3927 Ha of forest land for the subject project in Yadadri-Bhuvanagiri is **not agreed to**.
