Respected sir,

We had applied for the diversion of 0.4906 Ha. forest area diversion under Kutch forest division (0.4560 Ha. in Kutch west forest division and 0.0346 Ha. Kutch social forest division) vide proposal no FP/GJ/TRANS/143615/2021 dated 17.06.2021. The proposed transmission line is passing through unavoidable patches in Kutch West forest Division & Kutch Social Forest Division. Online proposal was submitted on Paravish portal date 17.06.2021 for diversion of **0.4906 ha.** (Kutch Social Forest Division, area: 0.0346 Ha. & Kutch West Forest Division, area: 0.4560 ha.).

However, due to location constrain & topography, one wind turbine location and associated transmission line is withdrawn from the said cluster. The withdrawn transmission line was passing through 0.4560 ha. forest area of Bagpat village in Kutch West Forest Division. Hence change in demanded forest area is as summarized below.
