No.62 and 69 of Agasur village, Sy. No. 40 of Heggarmakkigadda and Sy. No. 13 of Kavalalli village of Mastikatta Range, Ankola Taluk, Uttara Kannada district for construction of Vented barrage across Gangavali river to supply drinking water to Ankola, Karwar and project sea bird area. Hence it is submitted to consider the request of the user agency for diversion of 24.08 hectare of forest land for construction of Vented barrage across Gangavali river in forest land Sy. No.62 and 69 of Agasur village, Sy. No. 40 of Heggarmakkigadda and Sy. No. 13 of Kavalalli village of Mastikatta Range, Ankola Taluk, Uttar Kannada district on payment of Net Present Value, Compensatory Afforestation charges, Extraction charges and by imposing necessary conditions. The proposal under Forest Conservation Act 1980 is submitted in seven sets duly filling Part-II for further needful action in the matter.
