5-1: A Proposal has been received by this office from अधिशासी अभियन्ता, अस्थाई खण्ड, अस्थाई खण्ड, लोनिवि, घनसाली, मु-घुमेटीधार for diversion under (FCA-1980) of 4.447 ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of जनपद-टिहरी गढवाल के विकास खण्ड भिलंगना में मूलगढ ठेला गण्डराखाल मोटर मार्ग का भेलगढी से पांडवगांव तक विस्तार कार्य (लम्बाई-6.825 कि०मी०) The site inspection of the land involved in the proposal has done by me on date-21-10-2020.


