The Deputy Conservator of Forests, Dahanu has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/FCA/871, dated 07.09.2023. The Project Authority of this project is Executive Engineer, EHV Project Division-Kalyan, Tejashree Building, 2nd floor, Jahangir Ground, Karnik Road, MSETCL, Kalyan (W), Dist. Thane - 421 301.

2.00 The Project is for diversion of 3.3561 ha. forest land for construction of 132 KV Dahanu Ambesari Transmission line, for establishment of propose NHSRCL's 132 KV Ambesari Transmission line, District Palghar in the State of Maharashtra.

Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Proposed Forest land required for this Project is 3.3561 ha. The details are as given below:-

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Government of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps, which are also enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Dahanu has certified that the proposed area for diversion of 3.3561 ha. Forest Land for this project is at a distance of 63.397 Km. from Tungareshwar Wildlife Sanctuary and proposed alignment does not fall within Eco Sensitive Zone of Tungareshwar Wildlife Sanctuary.
- 6.00 The Deputy Conservator of Forests, Dahanu has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under it have not been violated in the Project.
- 7.00 The Deputy Conservator of Forests Dahanu has certified that there is cutting and felling of 196 trees in the project. Number of trees to be felled girth wise are as under, breakup and felling estimate enclosed in the proposal.

- 9.00 The Deputy Conservator of Forests, Solapur has proposed 6.7122 ha. degraded Reserved forest land from Comptt. No.91, Survey No.260, Gut No.962 and further certified that proposed degraded forest land is contiguous and suitable for Afforestation and Management purpose and also it is free from encroachment and encumbrances, 10 years Compensatory Afforestation Scheme is enclosed with the proposal along with requisite maps.

Executive Engineer, MSETCL, EHV Division, Kalyan has submitted a complete and final proposal on 03.07.2023 for Diversion of 3.3561 ha. Forest land for construction of 132 kv Dahanu-Ambesari Transmission line, for establishment of propose NHSRCL's 132 kv Ambesari Transmission line, Dist-Palghar. This project requires the area of Mangrove/Private Forest. Therefore the project authority is seeking GOI permission under Forest (Conservation) Act, 1980.

- 5) Brief Project detail from the Project Authority.
- 2.00 The Project Authority has given undertaking to pay the cost of Net Present Value as directed by Govt. of India. The Project Authority has submitted necessary certificate/undertakings and Maps, which are enclosed in the proposal.
- This office has certified that the provision of Forest (Conservation) Act, 1980 and its guidelines under the Act have not been violated by the Project Authority.
- The proposal is for the diversion of 3.3561 ha. Forest land for construction of proposed construction of 132 kv Dahanu-Ambesari Transmission line, for establishment of propose NHSRCL's 132 kv Ambesari Transmission line. Therefore Compensatory non forest land is not required. The Compensatory Afforestation on the area of double degraded forest land i.e.6.7122 ha. is proposed in Forest Division Solapur.

5.00 The Deputy Conservator of Forests, Solapur, Forest Division, Solapur has certified that 6.7122 ha. degraded forest land proposed for Compensatory Afforestation is suitable for Afforestation and Management purpose and its free from encroachment and encumbrances. Details of proposed degraded forest land for Compensatory Afforestation is given below table:

- 7.00 The proposed area involved in this proposal does not from part of any existing National Park, Wildlife Sanctuary, and Nature Reserve etc.
- 8.00 The proposed diversion area is at a distance of 63.397 km from Tungareshwar wildlife Sanctuary. and the Project will not have been any adverse effect on the Wildlife within National Park/Sanctuary.
- 9.00 The project involves felling of 196 trees in the area falling in diversion. Girth wise break up of trees are as under. The felling estimate of trees to be felled is enclosed in the proposal.

- 12.00 The proposed area of Diversion of 3.3561 ha. Forest land for construction of proposed construction of 132 kv Dahanu-Ambesari Transmission line, for establishment of propose NHSRCL's 132 kv Ambesari Transmission line. The demanded forest area is barest minimum.
- 13.00 The Project Authority has not submitted the FRA-2006 certificate from concerned collector. Regarding this, the necessary undertaking by the Project Authority is submitted and the same is enclosed in the proposal.
- 14.00 The proposed area have inspected the proposed diversion area on dated 16.05.2023. The site Inspection Report enclosed in the proposal.
- 15.00 This Project is undertaken by government of Maharashtra is part of public infrastructure facility. Hence the proposal is being recommended for approval and necessary acceptance under Forest (Conservation) Act, 1980.
