Field inspection notes of Sri.P.Sagar, Forest Divisional Officer, Banswada; the area proposed for Diversion of 0.6496 ha of forest land for upgradation of Road upto BT standards on exsting Road from Anjani Thanda to Pocharam Thanda via Shivapur Talab Thanda of Pedda Kodapgal Mandal in Kamareddy District of Banswada Division.

On 16.07.2019 inspected the Forest land proposed for diversion passing through Banswada Division for up gradation of Road upto BT standards on existing Road from Anjani Thanda to Pocharam Thanda via Shivapur Talab Thanda of Pedda Kodapgal Mandal along with the concerned forest department staff. The details are as follows:



Pitlam Range:





The proposed area is passing through Compartment No. 343, 344 Beat Jagannathpally, Kowlas RF, Kowlas Section of Pitlam Range. At some places I have verified the width of proposed road area passing through above compartments and found correct. Existing road width is 6 Mts and widening proposal is for 7.5 Mts width and total length in of the road is 0.80 km and total area proposed for diversion is 0.6496 ha. In the kowlas RF Block files it is traced out that the carterack is mentioned from Anjani to Pocharam village thoroughfare, hence complete width and length of area taken for diversion.

Talab Thanda

The Forest Range Officer, Pitlam has went to taken up enumeration of trees to be felled. But in the entire diversion area there is no tree growth of total length and width. Hence the tree enumeration is **NIL**.

The Forest type is Tropical dry deciduous with 0.1 to 0.2 density. In this proposed diversion area there is no forest works carried out till today like Plantation, smc works, wildlife management works etc..

The wildlife found the area is Peacock, wild boar, hare etc.

Other observations:

In my field inspection and reports from Forest Range Officer, Pitlam of this Division there is no encroachment land is present in proposed diverted forest area.

- The proposed area doesn't form part of National Park, wildlife sanctuary, biosphere reserve, tiger reserve, elephant corridor, etc.
- 2. No rare/ endangered/ unique species of flora and fauna found in the area.
- No protected archaeological/ heritage site/ defence establishment of any other important monument is located in the area.
- 4. No work is carried out in violation of Forest (Conservation) Act 1980.
