**SITE INSPECTION REPORT-NOT BELOW THE RANK OF DCF  
(for the forest land to be diverted under FCA)**

5.1 A Proposal has been received by this office from Indian Oil-Adani Gas Pvt. Ltd. for diversion under (FCA-1980) of 0.3025 Ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of laying of 8" NB Carbon Steel Gas Pipeline along NH - 74 (Rudrapur - Kichha Road at Left Side) from Km. 221.150 (Near Mahindra-Mahindra Plant, Lalpur, Rudrapur) to Km. 227.200 (HPCL Petrol Pump, In front of Hotel Neelkanth, Kichha Bypass, Kichha) of Total Km. 6.05 & 0.3025 Ha. (Protected Forest of 0.2740 Ha & Reserve Forest of 0.0285 Ha) in Forest Division Tarai Central, Rudrapur, District - Udham Singh Nagar, Uttarakhand. The site inspection of the land involved in the proposal has done by me on dated 26.10.2022

5.2 On inspection of the site, it is found that the land required by the user agency is a RF - 0.0285 Ha & PF - 0.2740 Ha of total measuring of 0.3025 Ha

5.3 The requirement of forest land as proposed by the user agency in col.2 part 1 is unavoidable and is barest minimum required for the project. (Yes)


