

Kangra HP has submitted a proposal for diversion of 7.39.91 ha of forest land in favour of Luni Power Company Private Limited Near Chimbal Har Home Stay, for the construction of 33 KV S/C transmission Line From Luni from Luni Pwer Company Private Limited Luni-I SHEP Switchyard to HPSEBL, 33 KV Sub Station under the provision of Forest Conservation Act, 1980. The user agency has agreed to pay for the raising of Plantation under Compensatory Afforestation over 15 ha.in P9P Bir C-5 amounting to Rs.3344000/- (inculuding admin charges & conrtigency charges) in liue of forest land diverted for the construction of 33 KV S/C transmission Line From Luni from Luni Pwer Company Private Limited Luni-I SHEP Switchyard to HPSEBL, 33 KV Sub Station within the jurisdication of Palampur forest division. The user agency has agreed to pay the net present value also under the provision. The documents pertaining to the proposal are enclosed in proposal folders in triplicate.
