

## Site Inspection Note

**Sub :-** The Project Site for Retail Outlet of M/s Bharat Petroleum Corporation Ltd., located at Khata No: 52, Plot No: 143, 144, Mauza – Khandail, Thana – Sherghati, in Sherghati - Cherki road was inspected on 23.02.2021.

The instant project site proposed for diversion of forest land (linear) for making entry and exit passage to Fuel Pump of BPCL by the applicant dealer Mr. Zubair Alam Khan, S/o Zahiruddin Khan, Village – Khandail, PO- Bishunpura, PS- Sherghati, Dist – Gaya, falls on Khata No: 52, Plot No: 143, 144, Mauza – Khandail, Thana – Sherghati, in Sherghati - Cherki road. The important point of site inspection report are:-

1. The proposed project requires land for entry and exit of vehicles for the proposed BPCL retail outlet, which has to pass through the linear Protected Forest along the RoW of Sherghati-Cherki road, which was notified as Protected forest vide Department of Environment, Forest and Climate Change, Government of Bihar's notification no. S.O- 400 dated- 31.12.1996.
2. There is no wildlife sanctuary located within 10 Km from the location of the proposed site.
3. The Forest area required for the project is 0.010875 Ha. The proposed site is barest minimum required for the proposed project.
4. The undersigned concurs with the report and recommendation of the concerned Deputy Conservator of Forest, Gaya Forest Division, Gaya.
5. The proposal may be sanctioned subject to the condition of payment of amount for NPV and compensatory afforestation by the User Agency.
