10	Position of Wildlife in general	Presence of wild animals is negligible. Wildlife like elephant (<i>Elephas maximus</i>) Wild boar (<i>Sus scrofa cristatus</i>), Barking deer (<i>Muntia muntjak</i>), Jackal (<i>Canis reus</i>), Hare (<i>Lepus nigricollis</i>), and Bison (<i>Bos gaurus</i>) occasionally movement in the forest land proposed for diversion but their population is very less. Birds like common doves (<i>Streptopelia chinensis</i>), mynas (<i>Acridotheres tristis</i>), Jungle crow (<i>Corvus macrocyaneus</i>), Indian cuckoo (<i>Eudynamis orientalis</i>), Parakeets (<i>Psittacula krameri</i>), etc are seen. Common reptiles and lizards like Indian cobra (<i>Naja naja</i>), Common krait (<i>Bungarus caeruleus</i>), Rat snakes (<i>Ptyas mucosus</i>), common garden lizards (<i>Calotes versicolor</i>) etc. are seen in the area.
