The proposal is for diversion of 0.3716 ha. forest land for regularization of lease of Forest land (Before 1980) for use of 33KV x 11KV Sub Station & other amenities from Survey No. 51 A, Gut. No. 77/1 at village Kshetra Mahabaleshwar Dist. Satara, to the MSEDCL Satara, under section 2 (ii) of Forest (Conservation) Act, 1980 in the State of Maharashtra.

3.0 The Maharashtra State Electricity Distribution Company Ltd. Uga Bhawan New Administrative Building Baramati District Pune Maharashtra is intending to seek an ex post facto approval of the Competent Authority, under provision of Forest (Conservation) Act, 1980, for diversion of Forest Land for continuing operations of existing 33/11 KV SubStation at Mahabaleshwar District Satara.

The land for the Sub-Station has been allotted by the Collector, Satara by an order dated 16/04/1974. The documents available on records suggests that the term of the lease is concluded in the year 1999.

However, since the land under lease attract the provisions under Forest (Conservation) Act, 1980, to be able to continue the operations, the MSEDCL has decided to obtain approval of the Competent Authority for diversion of use of the Forest Land.

The Sub-Station is catering the very basic need of local people and eventually the businesses, which are contributing substantially to the economy & development of the Mahabaleshwar city and adjoining villages. Since the project is already executed and is in operation from 1974, there is no alternative available with the MSEDCL, but to seek anapproval under Forest (Conservation) Act, 1980 available with the MSEDCL, but to seek an approval under Forest (Conservation) Act, 1980 for continuing operations of the Sub-Station.

After resurvey leased land has been done and now project authority has decided land under Sub-Station and other amenities should applied for regularization of leased and remaining forest lease to be given back to forest department. (PPN 27 & 28)

No. 77/1 at village Mahabaleshwar, Tal-Mahabaleshwar Dist. Satara to the MSDTCL Satara, But project authority has not applied for extention of lease period or not completed the procedure for regularisation of leased land.

4.12 The work for 33KV x 11KV Sub Station & other amenities from Survey No. 51 A, Gut. No. 77/1 at village Kshetra Mahabaleshwar Dist. Satara to the MSEDCL Satara has not applied for extend lease period or not completed the procedure to regularization of leased land.

The proposal for extension of lease period from 1974 to next 25 years (1999) was submitted and being chased with forest department at different level since long back but could not be materialized. Year 2004 forest department had advised to apply on Parivesh Portal.

Project Authority has submitted online proposal on FCA portal but it's also remain in draft stage for longer time. Project Authority has not completed processor under FCA 1980 for regularization of lease for construction of 33KV x 11KV Sub-Station and other amenities.

Hence Violation of Forest (Conservation) Act, 1980 and or its guidelines have been committed. In this project no new construction has been done after expiry of lease period. Certificate for violation of Forest (Conservation) Act, 1980 and Report regarding Violation is enclosed on (PPN 48 to 52)

- 7.0 The User Agency has submitted the certificates of Collector, Satara on Gram Sabha under Schedule Tribes and Other Traditional Forest Dweller's (Recognition of Forest Rights) Act, 2006 stated that forest area is already handed over to project authority in 1974 before inforcement of FRA 2006. In this proposal no new construction of building proposed, and filling of trees dose not involved. Hence, project authority requested to relaxation on certificate of Collector and also NOC resolution from Hills Station Municipal Council, Mahabaleshwar.(PPN 32).

- 8.0 The Deputy Conservator of Forests, Satara Forest Division, Satara and the Chief Conservator of Forest (T), Kolhapur have recommended the proposal for diversion of 0.3716 ha. of Reserved forest land. (PPN 20, 21 & 39)
- 9.0 KML file of the proposed diverted area and CA area is kept in the file at the top.
- 10.0 In view of this, the proposal is recommended for approval under the section-2 (ii) of the Forest (Conservation) Act, 1980 subject to the following conditions:
- 1. The legal status of the forest land required will remain unchanged.
- 2. Compensatory afforstation shall be taken up by the Forest Department over 1.00 ha double degraded Forest land on Forest Gut. No.483, Compt.No. 169 at Village Kholavadi, Tal. Wai, Dist. Satara at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 4. NPV:-
 - The State Government shall charge the Net Present Value (NPV) for the 0.3716 ha. forest area to be diverted under this proposal from the User Agency as per the Government of India guidelines dated 06/01/2022 and 19/01/2022.

- 5. For violation of the Forest (Conservation) Act, 1980 the User Agency shall pay 5 times Penal NPV as per para 1.21 of Handbook of guidelines issued vide Central Government letter dated 28/03/2019.
- 6. No trees shall be felled during implementation of the project. In case tree felling is required the User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 7. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (http://parivesh.nic.in/)

- 8. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 10. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 11. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.

The Net Present Value for the required forest land of 0.3716 ha, is Rs. 592996/- (Rs, Five Lakh Ninety Two Thousand Nine Hundred Ninety Six only) For violation in this project, The Project Authority has agreed to defray the cost of NPV and penal N.P.V. (NPV + 5 times NPV + 12% Interest Per year). Total Cost of NPV 592996 + Penal NPV 4672808-5265804/- (Rs. Fifty Two Lakh Sixty Five Thousand Eight Hundred Four only) This NPV is exactly as per the rules and calculation provided in the Govt. Resolution no FLD- 1002/CR-199/F 10 dated 19.12.2003 Govt. Maharashtra, & as per revised rate sanctionded by MOEF guideline Dt. 6th Jan 2022. (PPN 76)

- 5. For violation of the Forest (Conservation) Act, 1980 the User Agency shall pay 5 times Penal NPV as per para 1.21 of Handbook of guidelines issued vide Central Government letter dated 28/03/2019.
- 6. No trees shall be felled during implementation of the project. In case tree felling is required the User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 7. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (http://parivesh.nic.in/)
- 8. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 10. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 11. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
- 12. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 13. The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/)
- 14. The Proposal is submitted for perusal and necessary action & further submission to MoEF&CC, Government of India, New Delhi. This proposal is comes scenario-7 because of volition done by user agency. Such proposals are scrutinized & cleared by MoEFCC. Therefore kindly submit this proposal to GoI, MoEFCC.

Keeping in view the facts mentioned above, this proposal for diversion of 0.3716 ha. forest land for regularization of lease of Forest land (Before 1980) for use of 33KV x 11KV Sub Station & other amenities from Survey No. 51 A, Gut. No. 77/1 at village Kshetra Mahabaleshwar Dist. Satara, to the MSEDCL Satara in the State of Maharashtra is recommended.
