

**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF
(for the forest land to be diverted under FCA)**

1 A proposal has been received by this office from **PMGSY works, PIU Dugadda, Pauri Garhwal** for diversion under FCA-1980) of **9.541** ha. of forest land for non-forestry purpose that include 3.465 Ha RFL (Rajaji Tiger Reserve), 6.076 Ha. Civil Soyam Land (including 1.531 ha. for muck disposal). The project envisages the use of forest land for construction of Naudkhal Mala Kota motor road to Sirasu motor road **13.00 km**. The site inspection of the land involved in the proposal has been done by me on dated.....*15/10/19*

2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring **9.541** ha. *The details are as:*

- ① Reserved forest (Rajaji NP) = 3.465 Ha
- ② protected forest = 6.076 Ha (Civil Soyam)
