The work shall be completed in shortest period. 2. There shall be no camping of labour and machinery in the forest area and lightening of any fire or use of firewood from forest. 3. The UA shall not litter the forest area with oil, plastic, etc. 4. The conditions proposed by the District Forest Officer, Nizamabad shall be implemented. 5. The works shall not be done during 05:00 PM to 08:00 AM. 6. All the debris at the site of construction shall be removed immediately after construction. 7. The culverts / bridges shall be maintained and desilting shall be done once in 03 months to prevent sand / silt or other debris deposition/ for easy wildlife movement. 8. Signages on speed limit, not to litter with plastic items and wildlife movement/ protection shall be placed at every Kilometre on both sides. 9. Speed breakers shall be placed at every 500 Mts. 10. The UA agency shall make necessary payments under penal clause for the violation.
