It is submitted that, the proposals for diversion of 11.30 ha of forest land for formation of road from Y.Ramavaram to Pothavaram (via) M.Bhimavaram in Puttakota RF in Narsipatnam Division and Dummukonda RF in Kakinada Division in favour of Executive Engineer, R&B, Rajamahendravaram were forwarded by the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, Guntur in the reference 1st cited, for examining and to submit the remarks and recommendations.

Accordingly, the field inspection report along with Part-II & site inspection report were submitted to the Chief Conservator of Forests, Rajahmundry Circle, Rajamahendravaram vide reference 2nd cited duly recommending the proposal for an extent of 1.999 ha.

Further, the Chief Conservator of Forests, Rajahmundry Circle, Rajamahendravaram has issued instructions vide reference 3rd cited for re-examin the proposals in consultation with user agency due to change in the width and extent of the proposed area.

Accordingly, the Forest Range Officer, Addateegala has re-inspected the proposed road area and submitted reports vide reference 6th cited. The user agency has submitted the rectified proposals vide reference 9th cited above.

Further, the Site inspection was conducted on 18-01-2021 by me along with concerned officers & staff. As per my field inspection and inspection reports of the concerned officers and as per the proposals submitted by the user agency the following are the observations.

1. The total length of the proposed road in Addatheegala Range is 7312 Mtrs. Out of that, 4263.179 Mtrs passes through Dummukonda RF, 2617.653 Mtrs passes through Shesharai Enclosure and remaining length i.e., 431.168 Mtrs passes through Un-reserve land.
2. The part of the road is passing through Dummukonda R.F in compt.nos. 136, 140, 149, 150 and 154 over a length of 4263.179 mtrs.
3. Dummukonda R.F was notified under section.16 of Madras Forest Act,1882 in B.P.No.489, FortSt.George Gazette Dt.13.10.1942.
4. As per the proposals submitted by the User Agency, the proposed width is 9.00 mts.
5. As per the field inspection, 292 no.of trees are falling within the width of 9.00 mts.
6. The volume of the 292 trees is 246.489 cmt with a value of Rs.41,74,808/- and the Earth work is to be excavate is 30396.95 cum and its value is Rs.1,67,18,323/-. Then, the total destruction in the proposed road is Rs.2,08,93,131/-
7. The average density of the adjoining forest is 0.60.
8. The details of the area to be diverted are submitted hereunder.

9. The user agency has identified CA land over an extent of 11.88 ha near Uppalanka (v) of Kakinada Range, Kakinada Division.
10. The Forest Range Officer, Kakinada has submitted Action Plan, vide reference 10th cited above, for an amount of Rs.68.00 lakh for Afforestation of the above CA area (11.88 ha) including raising and its maintenance for 10 years.

In this connection, it is to submit that, the proposed area for diversion of 6.58 ha of forest land for formation of road from Y.Ramavaram to Pothavaram (via) M.Bhimavaram in Dummukonda RF of Kakinada Division in favour of Executive Engineer, R&B, Rajamahendravaram **may be accepted** as per the rules in vogue. The report of the Forest Range Officer, Addateegala is submitted herewith for favour of kind perusal.
