SITE INSPECTION REPORT AND VIOLATION REPORT

(For the Forest Land to be diverted under FCA)

A proposal has been received by this office from Electricals Executive Engineer, Transmission line, Golmuri, Jamshedpur. The user agency has applied (under FCA-1980) for **Diversion of 8.763 hectare of Forest Land for Construction of 132 KV D/C Bahragora-Dhalbhumgarh Transmission line.**

1. The site inspection of the land involved in the proposal has been carried out by the undersigned (Abhishek Kumar, Divisional Forest Officer, Jamshedpur Forest Division Jamshedpur) on date **30/01/2019 and 23/02/2019**. The list of official present during the inspection is given below:-

2. On inspection of the site, it was found that the land required by the user agency is a **Forest Area** measuring **8.763 ha**.
3. The Legal status of forest land as proposed by the user agency is as follows
PF 8.763 ha.
It is unavoidable and is barest minimum required for the project.
4. The forest land proposed for diversion comes under dry deciduous tropical forest. The forest is mostly degraded with some degraded plantation. The proposed land for diversion is in many fragment plots. The density of the forest ranges from 0 to 0.8 and average density is 0.4. The trees present in the forest are *Terninalia Arjuna*, *Vachellia nilotica*, *Bambusoideae*, *Ziziphus Mauritiana*, *Ficus racemosa*, *Gmelina arborea*, *Phoenix dactylifera*, *Mahua longifolia*, *Azadirachta indica*, *Albizia lebbeck*, *Bombax Ceiba*, *Dalbergia Sissoo*, *Arecaceae*, *Vachellia nilotica*, *Leucaena leucocephala*, *Mangifera indica*, *Azadirachta indica*, *Bombax Ceiba*, *Arecaceae* etc. There are 74 number of trees coming under Forest Land required for diversion the row of the road. At the time of operation bare minimum number of trees will be felled and the trees

having girth of 20 cm or less may be transplanted. The proposed land comes under Singhbhum Elephant Reserve. As the proposed land for division is mostly undulating with some hillocks in between the area needs soil & moisture conservation works.

5. There is no any protected archaeological/heritage site/defence establishment or any other important monument is located in the area.

6. (a) The user agency has not violated the provision of Forest (Conservation) Act, 1980 and no work has been started without proper sanction.
(b) The user agency has not violated the provision of the Forest (Conservation) Act, 1980.
