



DFO Rampur has submitted proposal for diversion of 12.9880 hac of forest land in favour of GEE CEE Hydro Power Pvt. Ltd. VPO Sarahan Tehsil Rampur, Distt Shimla H.P. for the construction of Kot Dogri SHEP (10 MW) within the jurisdiction of Rampur Forest Division, Distt Shimla HP for according necessary approval under section -2 of Forest (Conservation) Act, 1980. The proposal has been uploaded on web portal of forest clearance by DFO Rampur as per new guideline of online system.

Further it is submitted that DFO/UA has not placed the implementation agreement for the enhanced capacity in the project folders with reference to the allotment/ consent letter for the preparation of Project report for the hydel project issued by the Director Himurja, Urja Bhawan Kasumpti Shimla vide letter No. Himurja/SHP-Kot Dogri (GCHPPL)/2009-8049 dated 25.07.2009 and letter No. and letter no. Himurja/SHP-IA/Kot Dogri (GCHPPL)/2009-1484 dated 11.02.2015.

Therefore, the proposal folders in duplicate are submitted herewith for seeking necessary approval under section 2 of Forest Conservation Act, 1980.
