It might cause animosity between the villagers and the Government agencies. Forest Department works closely with these villagers towards sustainable development of the community, and conservation of flora and fauna. Hence, it is important that the villagers of the Western basin be compensated. One option would be to provide better water facilities to these villagers, funded from the project cost.</p> <p>Additionally, there is a Forest Nursery adjoining the project Site, hence, provision should be made for availability of water from the project to the nursery at free of cost.</p>
