

3 Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.	<p>The project involves diversion of water from west flowing basin to East flowing Godawari basin. It also aims to irrigate 57 ha. area of Nanashi Village, Dindori Taluka. However it is reported that there is dissatisfaction among villagers on diverting water from western basin to East Godavari basin.</p> <p>Moreover alternative land with minimal diversion of forest area is available but local MLA has opposed diversion of such land for the project. Hence forest land is proposed to be diverted for the project. The proposal may be recommended based on utility of the project.</p>
