With reference to the above, subject the proposal for diversion of 34.98 Ha has been submitted by the Assistant Executive Engineer, KUWS & D Board, Sub-Division, Karwar vide proposal No (FP/KAWATER/27276/2017) for construction of vented barrage across river Gangavali. In which 10.90 Ha (Out of. 34.98 Ha) falls in Hiregutti range of Honavar Division..


The Proposed area for diversion has been inspected by me on 01-10-2019 along with Range Forest Officer, Hiregutti and staff and necessary observations has been recorded and enclosed to the proposal. The area proposed for the diversion falls in Gundabala and Hillur village of Hiregutti range of Honavar Division.

The user agency yet to submit (1) Certificate related to ensuring compliance of the Scheduled Tribes and Other traditional Forest Dwellers (recognition of Forest Rights) (RoFR) Act 2006 as per the guidelines issued by Ministry of Environment and

Forests vide letter No./11-9/1998-FC (Pt), dated: 05-07-2013. (2) Non availability of non forest land duly obtained from compitant authority. And it will be submitted dirctly to Chief Conservator of Forests, Kanara Circle, Sirsi by User Agency.

The proposed diversion of forest land pertaining to the Honavar Division in (7) set is enclosed herwith duly filling Part-II for further needful action in the matter.
