A proposal has been received by this office from 26/06/2020 for diversion (under FCA, 1980) of **0.4178** Ha of forest land for non-forestry purpose. The subject envisages the use of forest land for construction of road from Panditgram to Chanseri.

1. The site inspection of the forest land involved in the proposal has been done by me on **19-02-2021**. On inspection of the site, it is found that the land required by the User Agency is forest land measuring **0.4178** Ha. The requirement of forest land as proposed by the UA in Col. 2 of Part-I is unavoidable and is barest minimum required for the project.
