13	Specific recommendations of the DCF for acceptance or otherwise of the proposals with reasons	<p>As the Project is to access agricultural fields, the proposal is recommended subject to the following conditions.</p> <ol style="list-style-type: none"> a) To pay an amount of Rs, 3.318 lakhs towards cost of NPV @ Rs.6.26 Lakh /Ha as per classification of Forest area. b) To pay Rs, 1.491 lakhs towards extraction charges and tree value as estimated. c) To pay Rs,5.70 lakhs towards construction of RCC pillars along the alignment of approach road. d) The User agency should bear the cost of raising & 10 years maintenance of cost of Compensatory Afforestation for Rs, 12.235 lakhs in Ibrahimpur degraded Reserve Forest in 4.60 Ha by planting 1840 Nos @ 400 plants/Ha. e) The user agency to pay Rs, 0.112 lakhs towards dibbling of Agave suckers including cost of sucker and transportation. f) To pay Rs,44.318 lakhs towards erection of GI chain link fencing on either side of alignment of approach road.
