



Inspection & Observation letter (recommendation)

On 17.04.2020 along with the fore Deputy Conservator of Forests, Dharwad Division, Dharwad and Range forest officer, Dharwad Range, Dharwad and field staff have inspected the Goa-Tamnar transmission line project proposed to pass through the forest areas of Dharwad Range of Dharwad forest division.

During inspection it is observed that Goa-Tamnar Transmission Line LILO of one ckt of Narendra(Existing)- Narendra (New) 400KV D/C Quad Transmission Line project, the proposed line passes through the below locations of Dharwad Range.

F.Sy No.130 Guladkoppa GPS Reading N-15 32 12.80 E-75 56 55.5,

F.Sy No.696 Kotur GPS Reading N-15 31 52.5 E-74 52 32.3 and

F.Sy No.257 Niralkatti GPS Reading N-15 32 12.80 E-75 56 55.5


The area to be diverted for the proposed Transmission Line LILO of one ckt of Narendra (Existing)-Narendra (New) 400 KV D/C Quad Transmission Line project in Guladkoppa is 2.295 Ha., Kotur is 2.408 Ha. and Niralkatti is 0.083 Ha. respectively. These areas have plantations and scrub forests. (The total area proposed to be diverted 4.786 ha)

The EDS had been raised to UA through Deputy Conservator of Forests, Dharwad Division, Dharwad to realign & find nearest alternative private land so that the above said forest patch may be avoided.

UA in their letter vide refrence No :Goa Tamnar Transmission Project Limited letter no; STL/GRID5/ GTTPL/20/167 dated 19-05-2020, have given some technical reasons and have stated that it is not possible to realign.

The said land is reserve forest land, which has scrub forest. The species found in these areas are flora viz. Bamboo, Nilgiri, Acacia, etc., and fauna such as peafowl, jackal, reptiles etc.,

Hence I recommend the diversion of above said forest area for the purpose of Goa-Tamnar Transmission Line LILO of one ckt of Narendra (Existing)-Narendra (New) 400KV D/C Quad Transmission Line project as per Forest (Conservation) Act-1980. This project should align itself with the Environment protection Act and other such acts/rules in using forest land. Sufficient protection measures should be taken in the usage, management and protection of forest resources and provide necessary resources during the fire season to mitigate it.
