### Site Inspection Report

Name of the Project:(Proposal No.FP/KA/IRRI/47729/2020)

Diversion of 0.419 Ha Belagavi Dn, and 0.541 Ha of Gokaka Dn, Total 0.96 Ha forest land for construction of Godachinmalki LIS, Stage-II (Laying of underground pipeline) in Gokak Dn, Rajankatti Sy No.1<sup>a</sup>, Khangaon Fs No. 755, Fs No.711, Fs No. 580, Fs No. 703 And FsNo. 762 villages of Gokak Taluka, Belgavi District.

The proposed project location is approximately 40 kms away by road from Belagavi District Head Quarters.

I have inspected the project site on 13-12-2021 along with the Range Forest Officer Gokak, Assistant Conservator of Forests Ramdurga and their staf and found the following:

The area proposed for diversion falls in Rajankatti Sy No.1<sup>a</sup>, Khangaon Fs No. 755, Fs No.711, Fs No. 580, Fs No. 703 And FsNo. 762 villages of Gokak Range, Ghataprabha Division, Gokak. Of Belgavi District. In Karnataka State.

The area proposed for diversion involves construction of Godachinmalki LIS, Stage-II (Laying of underground pipeline) and in some place the pipeline is situated along the boundary and there is no structure above the ground.

During my site inspection, the following are the observations:

The selection of site where the project, proposed for construction of Godachinmalki LIS, Stage-II (Laying of underground pipeline) is a relatively flat land covered with small trees of naturally grown species and department raised plantations. Some soil and moisture conservation works being takne up by the Dept, in the proposed area.



The Vegetation found in the proposed area for diversion consists of natural species like Mashwal (*Chloroxylon swietenia*), Tugli (*Albizzia amara*), Dindal (*Anogeissus latifolia*), Pachari (*Dalbergia lanceolaria*) etc.

Density of the proposed forest area is 0.25 and falls under Eco-Class III Open Forest type.

The area proposed for Diversion is not a part of any National Parks, Wildlife Sanctuary, Bio-Sphere Reserve, Tiger Reserve, Elephant Corridor and does not consist of any Archeological / Heritage site and Defense Establishment or any other important monuments.

No rare/endangered/Unique species of flora and fauna are found in the proposed diverted forest land.

Work in violation of Forest Conservation Act has been carried out by the User Agency.
