I have Inspected the location for diversion of a total area of 0.186 ha of forest land in T.Edaiyar RF (0.049 Ha), Thiruvennainallur RL (0.034 Ha), Iruvelpattu RF (0.103 Ha) of Ulunthurpet Forest Range for proposed Reconstruction of dilapidated Head Sluice, bed dam, Retaining wall and culvert in Malatar Channel at 12 locations at Iruvelpattu RF in Ulunthurpet taluk in Villupuram district on 01.03.2023 and 17.05.2023 along with Executive Engineer,

Water Resource Department, Lower Pennaiyar Basin Division, Villupuram with Field staffs of PWD and Forest Range Officer and staffs of Ulunthurpet range. The proposal for diversion of 0.186 ha of forest land located in Malattar river bed, covers T.Edaiyar RF (0.049 Ha), Thiruvennainallur RL (0.034 Ha), Iruvelpattu RF (0.103 Ha) are series of structure falling in the river course and the same is an irrigation project involving construction and reconstruction of structures and the total area for which diversion is sought is only 0.186 Ha.

It is a government project and construction and reconstruction works of dilapidated Head Sluice, Bed Dam, Retaining wall and culvert in Malattar Channel across Malattar River bed Forest area will fulfill the water supply to tanks in Tirukoilur and Villupuram taluks of Villupuram District. Since water supply is basic need to the Public this project is considered as essential.

There is no tree felling in the alignment. It does not fall in the Elephant corridor.
