


## संयुक्त स्थल निरीक्षण रिपोर्ट

दमोह जिले में प्रस्तावित तारादेही पौड़ी चंदना मार्ग निर्माण में दमोह वनमंडल के अंतर्गत प्रभावित वनभूमि के व्यपवर्तन/उपयोगार्थ हेतु 0.954 हे. आवेदित वनभूमि का संयुक्त स्थल निरीक्षण दिनांक 11.02.2020 को किया गया जिसमें मार्ग की लम्बाई-6360 मी० वनक्षेत्र अंतर्गत पाई गई जिसकी वर्तमान विद्यमान चौड़ाई-06 मी० है एवं मार्ग निर्माण में निर्माण कार्य 7.5 मी० किया जाना है जिसके चौड़ीकरण में 1.5 मी० चौड़ाई बड़ाने हेतु क्षेत्र प्रस्तावित किया गया है जो निम्नानुसार है:-
