The Deputy Conservator of Forests, Alibag has submitted the proposal in the captioned subject vide his letter No. A/20/Land/FCA/543, dated 28.06.2023. The Authorized Signatory and Project Authority of this Project is Mohammed Shakir Ansari Chief Manager (Construction) GAIL India Ltd, CBD Belapur, Navi Mumbai - 400 614.

- 2.00 The Project Authority has submitted a proposal for diversion of 3.9443 ha. forest land for Uran-Usar propane pipeline laying 12" Dia Liquid propane along with Optical Fiber Cable (OFC) in Tal Uran, Panvel, Pen & Alibag, Dist. Raigad in the State of Maharashtra.
- 3.00 Diversion of forest land is required from Uran-Usar propane pipeline laying 12" Dia Liquid propane along with Optical Fiber Cable (OFC). Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

The Forest land required for the project is 3.9443 ha. The details of the land proposed for diversion is as under.

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps, which are also enclosed in the proposal.
- 5.00 The Project Authority has given undertaking that the process of getting FRA-2006 certificate from Collector Raigad is in progress and will be submitted as and when received from the Collector Raigad.
- 6.00 The Deputy Conservator of Forests, Alibag has certified that the proposed land is not part of the Karnala Bird Sanctuary. The proposed area of the project is 5.34 km. away from the boundary of protected area (Karnala Bird Sanctuary) and 3.32 Km. from the boundary of the Eco Sensitive Zone of Karnala Bird Sanctuary. Further certified that the project is not falling in Eco Sensitive Zone of Karnala Bird Sanctuary.
- 7.00 The Deputy Conservator of Forests, Alibag has proposed area of 8.00 ha. degraded forest land of village Ambivali, Tal. Panvel Protected forest Survey No.45 and Village Nere, Tal. Panvel Protected Forest Survey No.34. Further certified that proposed degraded forest land is suitable for afforestation and management purpose and also it is free from encroachment and encumbrances 10 years Compensatory Afforestation scheme is enclosed with the proposal along with requisite maps.
- 8.00 The Deputy Conservator of Forests, Alibag has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under the Act have not been violated by the Project Authority.
- 9.00 The Deputy Conservator of Forests, Alibag has certified that the proposed project is not likely to affect any monuments, site of culture, historical, religious, archeological or recreational importance.
- 10:00 The entire area involved in this proposal does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve, etc.

11.00 The Deputy Conservator of Forests Alibag has certified that there is cutting and felling of 15034 number of trees in the said project. Number of trees to be felled girth wise are as under, breakup and felling estimate enclosed in the proposal.
