A copy of the Government of India, Ministry of Environment, Forests & Climate Change, Chennai F.No.4-TNC005/2015-CHN/651 Dated 10.07.2015 is enclosed herewith for kind perusal. As per the direction of the Government of India, Ministry of Environment, Forests & Climate Change, Chennai letter cited, the Commissioner, Theni Allinagaram Municipality, Theni has modified and submitted fresh online application under Section 2 of F(C) Act, 1980 in the "Others" category in the prescribed format of Form-A Part I for diversion of 0.01 ha of forest land in Valkaradu Reserved Forests of Theni Forest Division in Theni District for laying 200mm sewer line for 90 m length – Theni Allinagaram Municipality.

The User Agency has requested diversion of forest area for a period of 30 years.

 The User Agency has submitted the following details / documents/Certificates / Undertakings along with the proposal.

- 1. Demand for forest land for the project is minimum.
- No violation of the provision of Forest (Conservation) Act, 1980 occurred.
- Certificate obtained from the District Collector to effect that no alternate suitable non forest land is available for the project.
- 4.Undertaking to deposit the cost of raising compensatory afforestation and maintenance of plantation as fixed by the Forest Department and willingness to deposit additional amount if any suggested as amended owing to the change in planting technique, enhancement in the FSR etc., demanded subsequently.
- The User Agency has certified that no work in violation of the Forest (Conservation) Act, 1980 has been carried out for the Laying of sewer line involved in Theni Forest Division.
- Undertaking to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.
- Undertaking to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with escalation if any for the forest land to be diverted of the above project in future.
- The Forest Rights Act, 2006 Certificate issued by the District Collector of Theni on 22.04.2015 has been uploaded in the proposal.

After getting additional details from the User Agency, the proposal was forwarded to the District Forest Officer, Theni Forest Division, Theni.

After field inspection, the District Forest Officer, Theni Division and the Conservator of Forests Madurai Circle have forwarded the proposal.

The District Fcrest Officer, Theni Division has reported that the land required is less than 1 ha. Hence the requirement of compensatory afforestation land is does not arise.

The DFO, Theni has inspected the linear area proposed for the laying of sewage line Valkaradu Reserved Forests in Theni on 22.09.2015. He has reported that

a) The area has no trees and the area is located in gently undulating terrain. The area falls under the Vaigai Catchment.

- b) The linear area proposed for the laying of sewage line is 0.01 ha in area and is located right on the boundary of Valkaradu Reserved Forests adjacent to the Theni- Allinagaram Municipality residential area.
- c) There is no spontaneous tree growth in the proposed area. There is no endangered species of flora and fauna found in the proposed area.
- d) The proposed area for diversion does not have any important monuments which are archaeological / heritage site / defense establishment etc.
- e) In the proposed area, the user agency has not carried out any work, which contravenes the FCA 1980. Since there is no alternate route for inter connecting sewage lines, diversion is very much essential on this ground diversion of 0.01 ha is recommended.

The Conservator of Forests, Madurai has inspected the site proposed for laying sewage line in Valkaradu Reserved Forests with District Forest Officer, Theni and Forest Range Officer Theni on 14.11.2015. The linear area proposed for laying sewerage line is located right on the boundary of Valkaradu Reserved Forests adjacent to the Theni – Allinagaram Municipality Residential area.

The area proposed is barest minimum and absolutely essential. The Conservator of Forests recommends the proposal.

The District Forest Officer, Theni Division has recommended the proposal in the Part II format proposal

The Conservator of Forests, Madurai Circle has recommended the proposal in the Part III format proposal.

The proposal is recommended subject to the following conditions

- (i) The User Agency has to deposit the cost of raising compensatory afforestation in the degraded forest land over the area of 1.00 ha and maintenance of plantation as fixed by the Forest Department and willingness to deposit additional amount if any suggested as amended owing to the change in planting technique, enhancement in the FSR etc., demanded subsequently.
- (ii) The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.
- (iii) The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with escalation if any for the forest land to be diverted of the above project in future.

I request that the proposal may kindly be forwarded through on-line to GOI for obtaining concurrence of GOI for diversion of 0.01 ha of forest land in Valkaradu Reserved Forests of Theni Forest Division for laying 200 mm dia sewer line for 90 m length in Theni — Allinagaram Municipality in favour of Commissioner Theni — Allinagaram Municipality,
