

FIELD INSPECTION NOTES OF FOREST DIVISIONAL OFFICER, VENKATAPURAM DIVISION ON PROPOSED LAYING OF OPTICAL FIBER CABLE (OFC) IN THE EXISTING RIGHT OF WAY IN VENKATAPURAM RANGE OF VENKATAPURAM DIVISION IN FAVOUR OF M/S. RELIANCE JIO INFOCOMM LTD., HYDERABAD.

I have inspected all the sites in Venkatapuram range on 12.02.2019. The proposed area falling in various compartments of Venkatapuram and Venkatapuram Ext-I, Alubaka Ext-I, Nuguru, Peruru, Krishnapuram Reserve Forest Blocks and details are as furnished below.

The User Agency has proposed laying of Optical Fibre line within the admitted Right of Way and in the existing roads in different R.F.s of Venkatapuram Division in Venkatapuram and Venkatapuram Ext-I, Alubaka Ext-I, Nuguru, Peruru, Krishnapuram Reserve Forests R&B road from Alubaka to Krishnapuram of Venkatapuram Division. The details are as shown below.



In the proposed area, no rare / endangered / unique species of flora and fauna are found. Likewise no protected archaeological / heritage site / defense establishment or any other important monument is located. The User Agency has proposed for laying of OFC line within the admitted Right of way and existing roads in different RFs of Venkatapuram Division. In Venkatapuram and Venkatapuram Ext-I, Alubaka Ext-I, Nuguru, Peruru, Krishnapuram Reserve Forests / R&B road from Alubaka to Krishnapuram of Venkatapuram Division

The Proposed OFC is passing through the above Reserve Forests along the Existing R&B Road. The area is having different type of vegetations, which is having 0.3 Density. No trees are coming in earth work of 0.40mt wide along the R&B Road. Hence, no felling of trees required.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project. No work in violation of the Act has been carried out by the User Agency.

The laying of Optical Fiber Cable (OFC) will improve the digital communication and connectivity in the interior areas of LWE District of JayashankarBhupalpally.
