24	Specific recommendation of the DFO with reasons for approval of the project.	जियो डिजिटल फाइबर लिमिटेड द्वारा ओ.एफ.सी. केबिल लाइन कटना लास्ट मील तक सड़क के किनारे से डालने हेतु प्रस्ताव दिया गया है। प्रस्तावित केबिल लाइन वन परिक्षेत्र पर्वत के कक्ष क्रमांक पी- 560,561, एवं परिक्षेत्र मोहन्द्रा के कक्ष क्रमांक पी- 1267 से होकर गुजरेगी जो सड़क किनारे से डाली जायेगी। जिसमें 5100 मी.लंबाई एवं 0.50 मी.चौड़ाई कुल 0.255 हे. वन भूमि प्रभावित होगी जो कि न्यूनतम है। वन क्षेत्र से केबिल लाइन डालने से ग्रामीण क्षेत्र में दूर संचार की सुविधा होगी। अतः ओ.एफ. सी. केबिल लाइन बिछाने की अनुमति हेतु अनुशंसा की जाती है।
